

Privacy Notice Going Forward competition 2024

This Privacy Notice tells you about the information collected from you when you enter into an online competition, contest, quizzes and sweepstakes (altogether "Contest") and agree to your personal data being stored by GF. What personal data do we collect?

When you enter into a Contest, we may ask you for your name, address, contact telephone number and email address. If you are entering on behalf of a company, in accordance with the terms and conditions of the Contest, we may ask you for your company name, your job title, your work email and additional information about your company. We will retain your details in order to carry out the Contest, to contact you about the prize and/or notify you about the final winner. For the purposes of administering the Contest, the collection, use and processing of personal data may be completed by GF, its corporate companies or other third parties.

Why do we collect personal data?

We require this data for the purposes of administering the Contest, verifying eligibility and for fulfilment, delivery and arrangement of the prize.

What do we do with your personal data?

Your information is stored in our database and may be processed outside of the European Economic Area (EEA).

Such countries do not have the same data protection laws as Switzerland and EEA. Where the European Commission has not given a formal decision that such countries provide an adequate level of data protection, any transfer of your personal information will be subject to approved contract terms designed to help safeguard your privacy rights and give you remedies in the unlikely event of misuse of your personal data. Your data may be shared with third parties as reasonably required for GF to process and store your data in accordance with this privacy notice or respond to your request.

Our legal basis to use your personal data

- Our legal basis for using your personal data is that it is necessary for our legitimate interest in holding the Contest, for your participation in the Contest and in accordance with the terms and conditions between us.

How long do we keep your data for?

We keep your data for the duration of the Contest and thereafter for so long as you consent and as reasonably required in accordance with our record retention policy.

Keeping your personal information secure

We have appropriate security measures in place to prevent personal data from being accidentally lost, or used or accessed in an unauthorized way. We limit access to your personal data to those who have a genuine business need to know it. Those processing your data will do so only in an authorized manner and are subject to a duty of confidentiality.

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data breach where we are legally required to do so.

Your Rights

Under applicable data protection laws, you have rights

- of access to, rectification of, and/or erasure of your personal data;
- to restrict or object to its processing; and
- (in some circumstances) to require certain of your personal data to be transferred to you.

To the extent our processing of your personal data is based on your consent, you also have the right to withdraw your consent, without affecting the lawfulness of our processing based on your consent before its withdrawal.

To exercise your rights, you can contact us as set out above. You can also lodge a complaint about our processing of your personal data with our Corporate Data Protection Officer or a data protection authority.
