

# Terms and conditions Going Forward competition 2024

#### Organizer

The Going Forward competition 2024 (hereinafter "Contest") is organized by Georg Fischer AG, Amsler-Laffon-Strasse 9, 8201 Schaffhausen, Switzerland (hereinafter the "Organizer"). Participation in the Contest takes place solely in accordance with the terms and conditions described here.

## **Eligibility**

All natural persons who have reached the age of 18 at the time of participation may participate in the Contest (hereinafter "Participant(s)"). The Organizer reserves the right to exclude persons from participating at its discretion if there are justified reasons: for example, in the event of manipulation in connection with running the Contest, in the event of violations of these conditions of participation, or if false or misleading information is provided in connection with participation in the Contest.

#### **Participation**

Participation in the Contest is voluntary and independent of the purchase of goods and services.

In order to participate in the Contest, participants have to follow these steps:

- Take the most original photo or video possible of yourself together with the GF campaign on the screens at the airport in Zurich
- Post it on LinkedIn
- Tag GF and APG|SGA AG
- Use the hashtag #GoingForward

By posting the photo online with the #GoingForward, participants confirm that they have read the data privacy policy and accept the conditions of entry

Participants can only enter the competition once; participating multiple times or entering incorrect information will result in the loss of the right to participate

Participation is only possible up to the participation deadline. The competition starts on 08th July, 2024 and runs until 8th September, 2024.

## Winning, notification, and award of the prize

The advertised prizes are:

1st place: Bose Quiet Comfort headphones

2<sup>nd</sup> place: GF travel set in the value of 150 CHF

3rd place: GF travel set in the value of 100 CHF

The winner will be chosen by the organizer. The three most original photos receive a price and will be contacted by e-mail or Linkedln. The claim to the prize expires if the winner does not respond within fourteen days of being contacted by the Organizer. In this case, a new winner will be chosen by the organizer.

The prize will be sent as arranged within one month after the winner has been contacted. It is not possible to exchange the prize or receive a cash payment in lieu. The prize may not be transferred to another person.

## Termination of the competition

The Organizer expressly reserves the right to interrupt or terminate the Contest at any time without prior notice and without giving reasons and to amend these terms and conditions. The Organizer cannot ensure the availability and functioning of the Contest. The Contest can be terminated or withdrawn due to external circumstances or necessities, and such action will not give participants the right to lodge a claim against the Organizer.
